ARP Act (HEERF III) Quarterly Report  
Due April 10, 2022

As of March 31, 2022, Clarkson has drawn down \$3,109,879 of the \$3,429,611 awarded in ARP (HEERF III) Student Support funding.

\$3,117,950 has been disbursed to students. Clarkson chose to take a multi-tiered approach for eligibility and distribution:

- This initial distribution of the ARP Act funding was used to provide a \$600 supplement to students who had graduated in Spring 2021 that had previously been awarded \$340 under CRRSAA funding upon indication within the PeopleSoft Student Financials System that they had expenses related to COVID. This resulted in disbursing \$238,800 to 398 students.
- 611 Pell-eligible students enrolled in the Fall 2021 semester have been disbursed \$1,496,950.
- To date, 105 students have received \$140,200 through the Dean of Students. These students approached the Student Success Center requesting additional assistance with COVID financial needs. The students completed a form providing receipts or backup documentation for the amount they were requesting. A committee reviewed all these types of requests and determined who and how much was to be distributed to each student. The amount per student varied depending on the documented need.
- Remaining students were sent an activity guide within the PeopleSoft Student Financials system to indicate if they had expenses related to COVID. This pool of 2,068 students were disbursed \$1,242,000.

Distribution and drawdown of the remaining ARP funding is in progress.

ARP Act (HEERF III) Quarterly Report  
Due January 10, 2022

As of December 31, 2021, Clarkson has drawn down \$2,978,250 of the \$3,429,611 awarded in ARP (HEERF III) Student Support funding.

\$3,018,482 has been disbursed to students. Clarkson chose to take a multi-tiered approach for eligibility and distribution:

- This initial distribution of the ARP Act funding was used to provide a \$600 supplement to students who had graduated in Spring 2021 that had previously been awarded \$340 under CRRSAA funding upon indication within the PeopleSoft Student Financials System that they had expenses related to COVID. This resulted in disbursing \$238,800 to 398 students.
- 611 Pell-eligible students enrolled in the Fall 2021 semester have been disbursed \$1,496,950.
- To date, 25 students have received \$45,532 through the Dean of Students. These students approached the Student Success Center requesting additional assistance with COVID financial needs. The students completed a form providing receipts or backup documentation for the amount they were requesting. A committee reviewed all these types of requests and determined who and how much was to be distributed to each student. The amount per student varied depending on the documented need.
- Remaining students were sent an activity guide within the PeopleSoft Student Financials system to indicate if they had expenses related to COVID. This pool of 2,060 students were disbursed \$1,237,200.

Distribution and drawdown of the remaining ARP funding is in progress.

ARP Act (HEERF III) Quarterly Report  
Due October 10, 2021

As of September 30, 2021, Clarkson has drawn down \$2,346,550 of the \$3,429,611 awarded in ARP (HEERF III) Student Support funding.

\$2,961,880 has been disbursed to students. Clarkson chose to take a multi-tiered approach for eligibility and distribution:

- This initial distribution of the ARP Act funding was used to provide a \$600 supplement to students who had graduated in Spring 2021 that had previously been awarded \$340 under CRRSAA funding upon indication within the PeopleSoft Student Financials System that they had expenses related to COVID. This resulted in disbursing \$238,800 to 398 students.
- 612 Pell-eligible students enrolled in the Fall 2021 semester have been disbursed \$1,499,400.
- To date, 6 students have received \$11,080 through the Dean of Students. These students approached the Student Success Center requesting additional assistance with COVID financial needs. The students completed a form providing receipts or backup documentation for the amount they were requesting. A committee reviewed all these types of requests and determined who and how much was to be distributed to each student. The amount per student varied depending on the documented need.
- Remaining students were sent an activity guide within the PeopleSoft Student Financials system to indicate if they had expenses related to COVID. This pool of 2,018 students were disbursed \$1,212,600.

Distribution and drawdown of the remaining ARP funding is in progress.

ARP Act (HEERF III) 30-Day Report  
Due July 24, 2021

The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP) Act. Institutions that were previously awarded CARES Act funding, were automatically awarded aid under ARP. Drawdown of the available funding within G5 was an indication of acceptance of the award.

This funding is provided by the ARP's Higher Education Emergency Relief Fund (HEERF III), with a new formula requiring approximately half of the funding to be used by each institution to provide direct relief to students. Under the provisions of the ARP Act, Clarkson University has been awarded \$3,429,611 to be used for direct student support.

On June 24, 2021, Clarkson completed a drawdown of \$225,600 to cover a distribution of that same amount to 376 students on June 17, 2021 for emergency relief. This initial distribution of the ARP Act funding was used to provide a \$600 supplement to students who had graduated in Spring 2021 that had previously been awarded \$340 under CRRSAA funding upon indication within the PeopleSoft Student Financials System that they had expenses related to COVID.
